

Third VIPS International Law Moot Court Competition 3 Nov- 5 Nov 2016

EVENT REPORT

One of the most prestigious events organised by Vivekananda Law School, an integral part of Vivekananda Institute of Professional Studies, The VIPS International Law Moot Court Competition started in the year 2013 when its first edition was organised, followed by the second edition being organised in 2014 and the latest edition from 3rd to 5th November, 2016. The moot proposition, being based on International Law, provides a platform to students as well as the teachers to broaden their knowledge about the law beyond their nation and expands the scope for their practice as a lawyer in the future.

In this Edition, around 24 teams including an international team from Nepal participated. The event was supported by many sponsors, primarily, SCC Online, Eastern Book Company, Panasonic, Fusion Law School, Oro Foundation, Kadden Borris, Lawctopus and Law Updater. The inauguration ceremony was presided over by Hon'ble Mr. Justice C.K. Prasad (Chairman, Press Council of India), Mr. Ashok Sharma Wani (Dean, USLLS, GGSIPU), who were felicitated by Prof. Dr. I.M. Pandey (Director, VIPS). Prof. Dr. Rashmi Salpekar, Dean, VLS welcomed the respected guests and the teams for the event by throwing light on the importance of mooting and its significance in the life of a law student. Prof. Pandey enlightened the participants with his valuable and inspiring words while discussing International Law and its importance in the contemporary world.

On the second day of the event, after the preliminary rounds, 8 teams were qualified for the Quarter Finals to be held on the same day. After the Quarter Finals, 4 winning teams were selected for the Semi Finals to be held next day, i.e. on 5th November, 2016. Further, the two winning teams proceeded to the Final round and the team from Campus Law Centre, Delhi University bagged the first position in this grand event.

The Final Round was adjudicated by Hon'ble Mr. Justice V. Kameswar Rao (Judge, Delhi High Court) and Dr. Narinder Singh (Secretary General, Indian Society of International Law and Chairman, International Law Commission, United Nations). Hon'ble Mr. Justice V. Kameswar Rao expressed that the society is diverting from other professions towards law and complete transformation has taken place in the recent years. Dr. Singh, who, while reminiscing on his three decades spent as a practicing International lawyer and working with the Ministry of External Affairs, spoke on ever-increasing importance of International Law in today's globalised world.
